Annual Report 2011

Sally's Angels' Gifts in 2010 Included:

- Car repair for family of child with severe autism
- Train tickets for father to visit son sick with cancer
- Paid cell phone bill for family of infant critically ill due to medical error
- Helped purchase Ensure for chronically ill children
- Assisted with cremation costs for a young child; funeral, burial expenses
- Paid for facilitators for Infant & Loss Support Group
- Tuition to Kindermusik class for child with Angelman syndrome
- Helped pay for medicines needed by a child who has been in and out of hospital since birth
- A/C window unit for family of child with brain injury
- Medical equipment not covered by insurance for chronically ill child
- Counseling sessions for mother struggling with daughter's continually declining health
- Leukemia medications mother can't afford for 13-year-old patient
- Improvements to make home bathroom handicapped-accessible
- Diapers/supplies for family of very premature baby to go home
- Rented bounce house for holiday event for special needs kids
- Car seats for premature twins
- Hotel stay for parents of pediatric oncology patient going to Duke for a transplant
- WalMart gift cards for families of hospitalized children with chronic illnesses and often with unemployed parents
- Gas cards for hospital social workers to give to families of patients
- Rent/mortgage payments for several families with newly diagnosed or chronically ill children
- Paying utility bills for families of children in PICU, often with chronic illnesses, and usually when power was about to be terminated

These represent just a sampling of the types of requests that come to Sally's Angels for funding every year. If not for Sally's Angels, these needs would go unmet.

In 2011, Sally's Angels gave **\$30,913** to nearly 200 families in need.

Since inception, Sally's Angels has **raised \$191,698**, and **given \$163,207** in assistance to support families of critically and chronically ill children.
